WE PROVIDE SPEECH AND LANGUAGE THERAPY, OCCUPATIONAL THERAPY, PHYSICAL THERAPY, AS WELL AS VISION AND HEARING SERVICES. THE FRANKIE LEMMON SCHOOL HAS RECENTLY MOVED TO A NEW LOCATION IN RALEIGH, NC.
